

## **Specific Privacy Statement**

**"Public Stakeholder consultation on the 8th Adaptation to scientific and technical progress of exemptions 2(c), 3 and 5 of Annex II to Directive 2000/53/EC (ELV)" referred as "consultation" in the text**

### **1. OBJECTIVE**
