

## **Specific Privacy Statement**

**Public Stakeholder consultation on the “Review in the light of scientific and technical progress of exemptions 8(e), 8(f)(b), 8(g) and 14 and re-evaluation of entry S(i) of Annex II to Directive 2000/53/EC (ELV)” referred to as "consultation" in the text**

### **1. OBJECTIVE**

The objective of this consultation is to receive the views of stakeholders or people concerned by the topic of the consultation and potentially to publish them on the Internet, under the responsibility of the Head of the Unit “*B.3: Waste Management & Secondary Materials*”, Directorate-General Environment, acting as the Controller.
